1. A clarification is made to the Invitation to Bid concerning the Bid Opening time and location, which should now read as follows: "CATS will receive bids until 2:00pm local time on Tuesday, August 4, 2009 at which time the bids will be publically opened and read in Room 270/271 of the Charlotte-Mecklenburg Government Center (CMGC), 600 East Fourth Street, Charlotte, North Carolina 28202."

2. Several Plan Holders have made inquiries concerning Specification section 00820 (Insurance), which was re-issued in Addenda #1, where it increased the Umbrella Liability coverage require to \$50,000,000.00, and asked if this amount is correct.

Specification Section 00820 – Insurance, as it was re-issued as part of Addenda #1, is modified as follows. Part 1.0 – D. should read as “Umbrella Liability policy with minimum limits of \$5,000,000 (\$5 million).” All other portions of Section 00820 are unaltered.

Additional project information, response to issues raised during the Pre-Bid Meeting, response to additional interrogatories from prospective bidders and any additional requirements placed on this project and the Contractor will be formally addressed by means of Addenda to this Bid Advertisement, which will be posted on the North Carolina “Interactive Purchasing System” website (<https://www.ips.state.nc.us/ips/pubmain.asp>). These Addenda will be the only official source of additional information following the initial Bid Advertisement.
